Please note that the Main Street Middletown reserves the right to limit the number of vendors accepted into each category and vendor space is limited, space will be granted on a first come, first served basis. Applications will continue to be accepted as long as space is still available.

### Vendor Rules and Regulations

- Show time: 10 a.m. until 3 p.m., **rain or shine.**
- Set-up time: 7:30 a.m. - 9:00 a.m. (no setup times on Friday)
- All vehicles must be off the street by 9:00 a.m.
- No vehicles will be permitted back onto the street before 3:15 p.m.
- Vendor spaces are 10' x 15' (single) or 10' x 30' (double). Vendors must setup within their allotted space.
- All tents must be weighted properly.
- Display must be complete by 9:30 a.m. and remain intact until 3:00 p.m., which at that time you must begin teardown onto the sidewalk.
- No vendor will be permitted to breakdown before 3:00 p.m. Vendors who breakdown early will not be considered for future events.
- Vendors must have their wares off the street by 4:30 p.m. for street cleaning.
- We do not allow generators and electricity will not be provided to vendors.
- Please leave your display area as you found it – clean and free of litter.
- Limited to unique hand-crafted crafts and original art only. All craft items offered for sale must be hand-crafted by the participant renting the space.
- Vendors must be present to exhibit their displays during all festival hours.
- No commercially made items may be sold.

- Members of Vendor Committee will check your display on the day of the festival and will reserve the right to ask you to remove unacceptable items from your table. Failure to comply may result in closure of your space.
- No pets are permitted.
- This is a Rain or Shine event. No refunds will be issued after applicant has been accepted and checks have been deposited.
- All vendors are responsible for collecting and reporting Maryland Sales Tax.
- All vendors must provide their own tents, tables and chairs.
- When filling out your application, please print clearly and give a detailed description of your wares.
- Only those applications that are complete and include full payment will be accepted.
- This is not a food vendor application.
- If a crafter is not in their assigned space by 9:00 a.m., the space will be sold, and money will not be refunded.
- Crafters must stop all sales at 3:00 p.m. and clean up their space at the end of the day.
- The Middletown Main Street Committee reserves the right to limit the number of crafters accepted in a particular category.
- There can be no product changes or product line additions after an application is submitted and accepted.
